Dear Judge Woodruff:

This notice is filed on behalf of Flowroute LLC (Flowroute) pursuant to 4 CSR 240-2.062 (1) to advise of a change of name under which the company operates in the State of Missouri.

The records of the Commission will verify that Flowroute is a limited liability company duly organized and existing under and by virtue of the laws of Nevada. Its headquarters and place of business are located at 1221 2nd Avenue, Suite 330, Seattle, Washington. Flowroute acquired its certificate to provide basic local telecommunications, non-switched local and interexchange services under the name "**Flowroute LLC**." Flowroute has changed its corporate name to **Flowroute Inc.** and has filed an amended certificate of authority for a foreign corporation with the Missouri Secretary of State's Office. The Secretary of State has approved the Company's use of the name Flowroute Inc.

In support of this request, I have attached as Exhibit 1 a current Certificate of Good Standing issued by the Missouri Secretary of State for Flowroute Inc. I am also authorized to report that Flowroute has reviewed its contacts in the electronic filing and information system (EFIS) and there is no need for them to be updated.

In connection with this notice, subsections (C) and (D) of 4 CSR 240-2.062(1) require respectively the attachment of a notice to customers advising of the name change and an adoption notice and revised title page for the company's tariffs reflecting the name change. Flowroute was certificated by the Commission effective April 4, 2014 and at this time has no customers in Missouri and has not filed tariffs for Commission approval. For these reasons and for good cause appearing, Flowroute respectfully requests the Commission, pursuant to 4 CSR 240.2015, to waive the requirements of 4 CSR 240-2.062(1) (C) and (D).


