NOTICE OF LOCAL PUBLIC HEARING REGARDING PROPOSED RATE INCREASE

Based upon a request by the Office of the Public Counsel (OPC), a state agency responsible for representing the interests of consumers before the Missouri Public Service Commission (Commission), the Commission will be holding a local public hearing regarding proposed changes to the customer rates and charges of W. P. C. Sewer Company, Inc. (Company). The purpose of this local public hearing is to receive customer comments about the proposed changes to the Company's rates and charges, and to bring recent service-related problems to the Commission's attention.

The local public hearing will be held January 5, 2009, at State Fair Community College, Multipurpose Building, Room 220, 3201 West 16th Street, Sedalia, MO 65301. The night's activities will begin with an informal question-and-answer session starting at 5:30 p.m. – with the local public hearing starting at 6:00 p.m. The facility at which this local public hearing is being held meets the accessibility standards required by the Americans with Disabilities Act. Also, please note that the Commission will conduct this local public hearing through an interactive video-conference link with the Commission's office in Jefferson City, and that the Commissioners will take part in the hearing via the video-conference link.

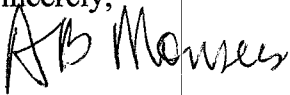
