

SUPPLEMENT TO APPLICATION

IDT America, Corp. ("IDT America" or "Applicant"), by its undersigned counsel, hereby submits this Supplement to Application in the above-captioned matter in response to the Notice and Order Directing Supplemental Pleading issued by the Commission on March 9, 2000. In its Notice and Order, the Commission requested additional information of the Applicant with regard to two issues, which IDT America answers as follows:


1. The proposed acquisition of selected interexchange customers of MCI WorldCom Communications, Inc. ("MCIW") by IDT America will not have any impact on the tax revenues of the political subdivisions of the State of Missouri where any structures, facilities or equipment are located. The proposed acquisition of selected interexchange customers by IDT America only involves customers and the associated accounts receivable. IDT America is not a facilities-based carrier and does not now maintain any structures, facilities or equipment in the State. Thus, the proposed transaction will have no impact on the tax revenue of any political subdivision of the State of Missouri.

2. IDT America is not aware of any pending or final judgements or decision against it from any state or federal agency that involve customer service or rates.

3. The Verification of a corporate officer of IDT America is provided herewith.

WHEREFORE, Applicant respectfully requests that the Commission approve the proposed transfer of the selected customer assets of MCI WorldCom, Inc. to IDT America, Corp. and grant all other relief as necessary and appropriate to effectuate the proposed transaction described herein.




