Dear Mr. Woodruff,

CBTS Technology Solutions LLC (CBTS-TS) is submitting this supplement filing in Case No. DN-2018-0304. With this filing, CBTS-TS is providing the Commission with the Missouri Secretary of State information, the customer notice information and reference to EFIS; all of which should have been included with the initial name change filing.

Through a series of Delaware and Missouri Secretary of State transactions, copies which are attached as Exhibit A, effective September 29, 2017, CBTS Technology Solutions LLC filed, and the Missouri Secretary of State approved, an Application for Registration of a Foreign Limited Liability Company. Thereafter, as required by law, the company filed a Request for Tax Clearance with the Missouri Department of Revenue, under the name then appearing on the Department's record, Cincinnati Bell Any Distance Inc. On October 31, 2017, the Missouri Department of Revenue issued the requested Tax Clearance Certificate. Effective November 1, 2017, CBTS Technology Solutions Inc. filed, and the Missouri Secretary of State approved, an Application for Certificate of Withdrawal, again under its registered name, Cincinnati Bell Any Distance Inc. Because of these filings, the Missouri Secretary of State issued a Certificate of Registration for CBTS Technology Solutions LLC, a Certificate of Withdrawal for Cincinnati Bell Any Distance Inc. and a new charter number, FL001421571, to replace the number under which Cincinnati Bell Any Distance Inc. had been registered, F00378717.

A customer notice in the form of a bill message was provided to all customers stating: "Cincinnati Bell Any Distance Inc. has converted to a limited liability company and changed its name to CBTS Technology Solutions LLC. This change has been processed by the appropriate authority (ies) in your state. Effective January 1,2018, you will see this name change reflected on your bills. This change does not affect your service or rates, including any of your rights or obligations."

In addition, CBTS-TS reviewed and updated the Electronic Filing and Information System.
