It was anticipated at that conference that if no additional revenue matters were discovered at the local public hearing held on August 18, 2008, new disposition agreements and tariffs would be filed and those disposition agreements would most likely be unanimous. Therefore, the Commission will set a date for Public Counsel to file its position in this case and/or for the filing of new

disposition agreements and tariffs. In addition, in preparation for the possibility of unanimous agreements proposing an expedited tariff effective date, the Commission will reserve a date for a hearing to present the agreements.

IT IS ORDERED THAT:

- 1. No later than August 26, 2008 at 12:00 p.m., the Office of the Public Counsel shall file its statement of position regarding these general rate requests.
- 2. No later than August 26, 2008 at 12:00 p.m. the parties shall file unanimous disposition agreements or a status report stating whether the parties intend to file such agreements.
- 3. If the Office of the Public Counsel has entered into a unanimous agreement, it may be excused from making the filing required in Ordered Paragraph 1.
- 4. The parties are hereby notified that if unanimous disposition agreements are filed, a hearing regarding those agreements may be set on August 27, 2008, beginning at 10:00 a.m., in Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. The Governor Office Building meets accessibility standards required by the Americans with Disabilities Act. - 5. If a hearing is held, the transcript will be expedited to be filed within one business day following the hearing.
