

On November 18, the Staff of the Commission filed its Recommendation stating that the tariff sheets filed by Missouri-American are in compliance with the Stipulation and Agreement. In light of Staff's recommendation, the Commission will approve the tariff sheets.

Missouri law<sup>1</sup> requires that unless otherwise ordered by the Commission, no change in Missouri-American's tariffs shall go into effect on less than 30 days' notice to the Commission. Because the Agreement sets out an effective date of November 28, 2008, and that date is less than 30 days away, the Commission will grant Missouri-American's request for expedited treatment.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheets filed by Missouri-American Water Company and assigned tariff tracking numbers YW-2009-0362, YW-2009-0363, YW-2009-0364, YW-2009-0365, YS-2009-0366, YS-2009-0367, YW-2009-0368, YW-2009-0369, YW-2009-370 and YW-2009-0378 are approved to become effective on November 28, 2008.
