MOTION FOR CORRECTION AND MODIFICATION OF ORDER

COME NOW Reduced Rate Long Distance, LLC (“RRLD”) and Horizon Telecom, Inc. (“Horizon”) (together “Applicants”), by and through undersigned counsel and pursuant to 4 CSR 240-2.160 (4), and hereby jointly request correction and modification of the Commission’s *Order Approving Transfer of Assets, Cancelling Certificate and Approving Tariffs* (“the Order”) issued July 25, 2008, in the following particulars:

1. Although both the title of the Order and the last paragraph before the ORDERED sections state that the Commission has approved the underlying transaction, as well as the revised tariffs, there is no “ORDERED” section that explicitly grants approval of the underlying transfer of assets. This appears to be a simple oversight. Applicants respectfully request that a corrected order be issued which specifically orders approval of the transfer of assets proposed in this case, or which specifically grants the Joint Application in this case, in an ORDERED section.

2. The Order also cancels Horizon’s certificate and tariff, as requested in the Application, but does so effective on August 6, 2008, when the Order and the revised tariffs become effective. Typically, this type of order would have required the parties to notify the Commission upon closing of the transaction, and the Commission would then cancel the certificate and tariff of the acquired company.¹ Since the underlying transaction will not

have closed as of August 6, Applicants request that the Order be modified to not cancel Horizon's certificate and tariff as of yet, but to require Applicants to notify the Commission once the transaction has closed. The certificate and tariffs of Horizon can be cancelled at that time.

3. A typographical error in ORDERED: 2 should also be corrected: "The certificated of service authority" should be "The certificate of service authority".

WHEREFORE, for the reasons stated herein, Applicants respectfully request that the Commission correct and modify its *Order Approving Transfer of Assets, Cancelling Certificate and Approving Tariffs* issued July 25, 2008 in the manner specified above, *nunc pro tunc* pursuant to 4 CSR 240-2.160 (4).
