ORDER REGARDING COMPLIANCE TARIFF SHEETS

Issue Date: May 21, 2014

Effective Date: June 4, 2014

On April 30, 2014, the Commission issued a report and order that rejected Lake Region Water & Sewer Company's ("Lake Region") tariffs to increase the company's annual revenues for its provision of water and sewer service. However, the Commission authorized Lake Region to file new tariff sheets sufficient to recover revenues as determined in that report and order. Lake Region filed its compliance tariff sheets on May 5, 2014, to become effective on June 4, 2014.

The report and order directed the Commission's Staff to file a recommendation regarding Lake Region's compliance tariff sheets by May 19, 2014 and directed any other party wishing to file a recommendation regarding the compliance tariff sheets to do so no later than May 19, 2014.

On May 19, 2014, the Commission's Staff filed its recommendation, which concluded the tariff sheets comply with the Commission's report and order and recommends the Commission approve the compliance tariff sheets to be effective on June 4, 2014. No other party filed a recommendation or response.

The Commission has reviewed the proposed tariff sheets and Staff's recommendation. The Commission independently concludes that the submitted compliance tariff sheets are consistent with the Commission's report and order, so the Commission will approve Lake Region's tariff sheets to become effective for service rendered on and after June 4, 2014.

THE COMMISSION ORDERS THAT:

1. The proposed water service tariff sheets submitted under Tariff Tracking No. YW-2014-0447, by Lake Region Water & Sewer Company, are approved effective on and after June 4, 2014. The specific tariff sheets approved are:

2. The proposed sewer service tariff sheets submitted under Tariff Tracking No. YS-2014-0448, by Lake Region Water & Sewer Company, are approved effective on and after June 4, 2014. The specific tariff sheets approved are:
