NOTICE OF AGREEMENT ON EXTENDED DEADLINES

COMES NOW, the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and pursuant to 4 CSR 240-3.050(12), hereby states:

1. On June 25, 2013, the Missouri Public Service Commission (Commission) received a letter from Roy-L Utilities, Inc. (the Company), requesting Commission approval of an increase of \$8,072.00 in its annual water system operating revenues and an increase of \$10,378.00 in its annual sewer system operating revenues, pursuant to Commission Rule 4 CSR 240-3.050, Small Utility Rate Case Procedure. The Company's requests for its sewer and water operations were assigned Commission Case Nos. WR-2013-0543 and SR-2013-0544, respectively.

2. Commission Rule 4 CSR 240-3.050(12) provides that "staff and the small utility may agree that the deadlines set out in sections (9), (10), and (11) be extended for up to two (2) months. If an extension is agreed upon, the staff shall file a written agreement regarding the extension and an updated timeline reflecting the extension in the case file."

3. Pursuant to Rule 4 CSR 240-3.050(12), Staff notifies the Commission of an agreement between Staff and the Company to a 60-day extension of the deadlines set out in sections (9), (10), and (11).

4. Updated timelines reflecting the requested 60-day extension are attached hereto as Appendix A, for WR-2013-0543, and Appendix B, for SR-2013-0544.

WHEREFORE, Staff notifies the Commission of an agreement between Staff and the Company to a 60-day extension of the deadlines set out in sections (9), (10), and (11) of 4 CSR 240-3.050.
