May 15	Last day for any party to serve data requests.
May 31	All data request responses filed in EFIS.
June 5	Stipulation of all undisputed facts filed.
June 22	Evidentiary hearing.

THE COMMISSION ORDERS THAT:

1. The procedural schedule shall be as set forth in the body of this order.
2. The Commission will convene an evidentiary hearing on the merits of the complaint at the Commission's offices in the Wainwright Building, 111 North Seventh Street, St. Louis, Missouri, on June 22, 2018, at 3:00 p.m.


