ORDER TO PROVIDE NOTICE REQUIRED BY SECTION 393.275.1 TO CITIES AND COUNTY OF RATE INCREASE

Issue Date: May 23, 2018 Effective Date: May 23, 2018

Pursuant to Section 393.275.1, RSMo 2016, the Commission must notify the governing body of each city or county imposing a business license tax on gross receipts of any approved rate increase that exceeds seven percent. Further, the statute requires the Commission to:

[i]nclude with such notice to any city or county the percentage increase approved for the utility, together with an estimate of the annual increase in gross receipts resulting from the tariff increase on customers residing in that city or county.

Section 393.275.2 then requires the taxing authority to reduce its tax rate to reduce the amount of revenue collected under the tax. Missouri-American Water Company ("MAWC") submitted a response identifying the governing bodies that should receive notice. The information provided by MAWC, including MAWC's revenue increase estimates, is attached to this notice.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall mail a copy of this order and *MAWC*'s Response to Notice to each city or county identified by Missouri-American Water Company.

2. This order shall be effective when issued.
