# ORDER SETTING DEADLINE FOR OBJECTIONS AND STAFF RECOMMENDATION ON COMPLIANCE TARIFFS

On May 9, 2018, the Commission issued a *Report and Order* regarding Gascony Water Company's ("Gascony") request for an increase in annual water system operating revenues and directing Gascony to submit revised tariff sheets in compliance with that order. On May 22, 2018, Gascony filed revised tariff sheets that were assigned tracking number YW-2018-0159.

The Commission will set a deadline for the Commission's Staff to file a report indicating whether the tariff sheets are in compliance with the Commission's May 9, 2018, *Report and Order*. The Commission will also set a deadline for the filing of objections asserting that Gascony's tariff sheets are not in compliance with the Commission's order.

# THE COMMISSION ORDERS THAT:

1. No later than June 4, 2018, the Commission's Staff shall file a report on the compliance of Gascony Water Company's tariff sheets (Tracking No. YW-2018-0159) with the Commission's May 9, 2018, *Report and Order*.

2. No later than June 7, 2018, any other recommendations regarding the compliance of Gascony Water Company's tariff sheets (Tracking No. YW-2018-0159) with the Commission's May 9, 2018, *Report and Order* may be filed.

3. This order shall be effective when issued.
