**NOTICE ACKNOWLEDGING DISMISSAL OF COMPLAINT  
AND CLOSING FILE**

Issue Date: December 29, 2016

On September 30, 2016, the Commission's Staff filed complaints against the Respondents alleging that Missouri Utility Company failed to pay its water and sewer assessments for 2014. The sewer complaint - File No. SC-2017-0096 - was subsequently consolidated into this file. On December 28, Staff filed a motion seeking leave to dismiss its complaints, indicating the company has now paid its past-due assessments.

Commission Rule 4 CSR 240-2.116(1) provides that a complainant may dismiss its complaint at any time before prepared testimony has been filed without an order from

the Commission. No prepared testimony has been filed in this case, so Staff does not need leave to dismiss its complaints, and the Commission will simply acknowledge their dismissal. This file may now be closed.<sup>1</sup>
