ORDER RELEASING DATES AND DIRECTING RESPONSE TO UPDATED AGREEMENT

Issued: July 24, 2014

Effective: July 24, 2014

Staff filed a *Notice of Updated Staff/Company Agreement Regarding Disposition of Small Company Rate Increase Request*¹ (“updated agreement”). The updated agreement states that substitute tariff sheets (“tariff”) are forthcoming. Those filings are to supersede the original settlement agreement² and pending tariffs³ that were filed under the procedures of notice, comment, and request for hearing in a small utility rate case.⁴

Those small utility rate case procedures do not apply now because the Office of Public Counsel (“OPC”) exercised its right to an evidentiary hearing,⁵ and the Commission suspended the pending tariffs,⁶ instituting a contested case.⁷ Also, the contested case procedural schedule is

suspended⁸ at the request of all parties.⁹ Therefore, the Commission will order OPC to file a response to this order addressing the updated agreement.

The Commission will also release the dates originally scheduled for an evidentiary hearing, now reserved for Commission inquiry, because those dates are the day this order issues and the day after. That time is too short for meaningful notice and inquiry into the updated agreement. Therefore, the Commission will release those dates.

THE COMMISSION ORDERS THAT:

1. The dates reserved for Commission inquiries are released.
2. The Office of the Public Counsel shall file a response to this order no later than August 4, 2014.
3. This order is effective immediately on issuance.
