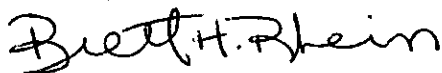
To whom it may concern,

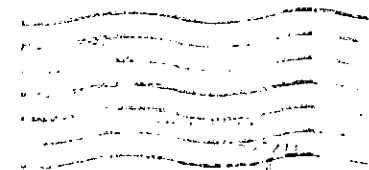

ORDER DIRECTING FILING

On November 7, 2003, the Office of the Public Counsel filed a complaint against Warren County Water and Sewer Company. On November 10, Public Counsel amended his complaint. The Commission issued its Notice of Complaint on November 12, 2003, advising Respondent of various options open to it and further advising Respondent that it must pursue one of these options by December 12, 2003. However, the Commission received neither a response nor any other contact from Respondent by that date.

Accordingly, pursuant to Commission Rule 4 CSR 240-2.070(9), the Commission issued its Order Granting Default on January 6, 2004, effective January 16, 2004. That order advised Respondent that it could move the Commission to set aside the Order Granting Default within ten days of the effective date of that order, that is, by January 26. Again, the Commission has received nothing from Respondent.

At this point, the Commission will direct its Staff to investigate the circumstances and file its report thereof on or before March 26, 2004.

IT IS THEREFORE ORDERED:

1. That the Staff of the Missouri Public Service Commission shall investigate the allegations contained in the Complaint and shall file its written report and recommendation herein not later than March 26, 2004.

2. That this order shall become effective on February 26, 2004

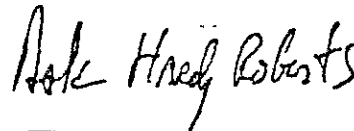

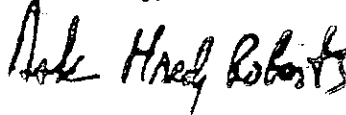
