APPLICATION OF

FOR APPROVAL OF INTERCONNECTION AGREEMENT

COMES NOW, Sprint Spectrum L.P. d/b/a Sprint PCS (Sprint PCS) and hereby files this Application for Approval of Commercial Mobile Radio Services (CMRS) Interconnection Agreement (the Agreement) under the Telecommunications Act of 1996 (the Federal Act) and in support show the following:

I. APPLICANT

Sprint PCS is a Delaware limited partnership with principle offices at 4900 Main Street, Kansas City, Missouri 64112. Sprint PCS is authorized to transact business within the State of Missouri and is authorized by the Federal Communications Commission ("FCC") to provide Commercial Mobile Radio Services ("CMRS") within the State. A copy of the Registration of Fictitious Name and Certificate of Limited Partnership issued by the Missouri Secretary of State are attached as Exhibit I. Sprint PCS provides wireless communications services.

Sprint PCS is not subject to Commission assessment or annual reporting requirements, consequently, no assessment or annual report is overdue. In addition, there are no pending actions or final unsatisfied judgments or decisions against it involving customer service or rates occurring within the last 3 years.

II. INTERCONNECTION AND RESALE AGREEMENT REACHED

Applicant presents to the Missouri Public Service Commission (Commission) for approval an agreement (attached as Attachment I) negotiated and executed pursuant to the terms of the Federal Act. After weeks of intensive good faith negotiations to address all of the complex issues involved in such an agreement, the parties executed the attached Commercial Mobile Radio Services Interconnection Agreement between Sprint Spectrum L.P. and AllTel Communications Service Corporation. There are no outstanding issues related to resale or interconnection between Sprint and ALLTEL Communications, Inc. that need the assistance of mediation or arbitration.

III. REQUEST FOR APPROVAL

Sprint Spectrum L.P. d/b/a Sprint PCS (Sprint PCS) seeks the Commission's approval of the Commercial Mobile Radio Services Interconnection Agreement, consistent with the provisions of the Federal Act. Sprint PCS believes that the implementation of this Agreement complies fully with Section 252(e) of the Federal Act because the Commercial Mobile Radio Services Interconnection Agreement is consistent with the public interest, convenience and necessity and does not discriminate against any telecommunications carrier. The Commercial Mobile Radio Services Interconnection Agreement promotes diversity in providers, provides interconnectivity, and increases customer choices for telecommunications services.

Sprint PCS respectfully requests that the Commission grant expeditious approval of this Agreement, without change, suspension or other delay in its implementation.

III. STANDARD FOR REVIEW

The statutory standards of review are set forth in Section 252(e) of the Federal Act which provides as follows:

Section 252(e) of the Federal Act:

- (e) Approval by State Commission
 - (1) Approval Required. Any interconnection agreement adopted by negotiation or arbitration shall be submitted for approval to the State commission. A State commission to which an agreement is submitted to shall approve or reject the agreement, with written findings as to any deficiencies.
 - (2) Grounds for Rejection. The State commission may only reject-
 - (A) an agreement (or any portion thereof) adopted by negotiation under subsection (a) if it finds that-
 - (i) the agreement (or portion thereof) discriminates against a telecommunications carrier not a party to the agreement, or
 - (ii) the implementation of such agreement or portion is not consistent with the public interest, convenience, and necessity; or

The Applicant states that the agreement is consistent with the public interest, convenience and necessity in that it allows for full and fair competition and greater choice for the consumer. The Applicant further states that the Agreement does not discriminate against other carriers not a party to the Agreement as the terms of the Agreement are equally available to any other carrier.

WHEREFORE, for the foregoing reasons, Applicant prays that the Commission approve the attached Commercial Mobile Radio Services Interconnection Agreement expeditiously and without change or alteration.
