### STAFF'S COMPLIANCE TARIFF RECOMMENDATION

**COMES NOW** the Staff of the Missouri Public Service Commission, through counsel, and states as follows.

1. On August 10, 2022, 188 North Summit, LLC ("188NS") and Seges Utility Company, LLC ("Seges") filed their *Joint Application and Motion for Waiver* ("Application") requesting that the Commission authorize 188NS to sell its water and sewer assets to Seges. The parties also requested that the Commission grant Seges a new certificate of convenience and necessity ("CCN") to provide water and sewer service in the territory 188NS currently serves.

2. On November 1, 2022, Staff filed its recommendation recommending approval of the transfer, with conditions.

3. On November 11, 2022, 188NS and Seges responded to Staff's recommendation, stating they have no objection to Staff's proposed conditions. No other parties responded to Staff's recommendation, and the deadline for doing so has passed.

4. The Commission has not issued an order regarding the Application.

5. On November 23, 2022, Seges filed revised tariff sheets bearing proposed effective dates of December 23, 2022.

6. On November 28, 2022, Seges filed a substitute tariff sheet to correct a typographical error. The initial submittal incorrectly used the word "water" to describe the sewer system. This substitute tariff sheet bears an effective date of December 23, 2022.

7. On November 30, 2022, the Commission directed Staff to file a recommendation by December 9, 2022.

8. Staff reviewed all tariff sheets and finds them consistent with Staff's recommendation.

9. Therefore, under the premise that the Commission issues an order granting

Seges a CCN consistent with Staff's recommendation and conditions, Staff recommends

approval of the following tariffs as compliant with such an order granting a CCN:
