On June 19, 2017, Gascony Water Company, Inc. (Company) submitted a request for an increase in its annua water operating revenues to the Missouri Public Service Commission (Commission). The reason for the increase it to cover increases in operating expenses and investments in the Company's facilities since current Company rate; were approved in April, 1999.

By its request, the Company is seeking changes to its customer rates intended to generate an increase in its annual water operating revenues of \$15,000 (approximately 44.28%), respectively. In addition, the Company is proposing the current rate design be changed. Specifically, the Company is requesting that the customer equivalent factor for part-time residential customers be increased from the current equivalent factor of .35 part-time custome to the Company proposed equivalent factor of .5 part-time customers. At the end of this notice is a table tha compares the Company's current residential customer rates and the proposed residential rates.

To provide comments regarding the Company's revenue increase request, or comments regarding service related problems, please contact the Commission Staff and/or the Office of the Public Counsel (Public Counsel within 30 days of the date of this notice. Your comments should include a reference to case number WR-2017 0343. The Commission Staff and the Public Counsel will review all customer comments submitted in response to this notice.
