**SECOND REQUEST FOR EXTENSION OF TIME**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through Counsel, and for its *Second Request for Extension of Time* states the following to the Missouri Public Service Commission ("Commission").

1. On August 25, 2005, Staff requested an extension of time to file its recommendation so that it could obtain the data, make appropriate calculations, meet with the involved parties, and attempt to reach an agreement with those parties with regard to the pipeline extension contracts.

2. In its August 29, 2005, *Order Extending Time for Staff to File A Recommendation*, the Commission approved Staff's Request, thereby extending the date to October 25, 2005.

3. During Staff's continued involvement and investigation in this case, it has been determined that the applicants have talked with the developers and provided new contract language for their review. As of this date, there are still issues regarding said language. Talks with the applicant reveal that more time is needed to finalize the contract between the parties.

4. Staff requests an extension to December 27, 2005, so that it can continue to obtain data and assist in mediating negotiations for the contract between the applicants and the developers. Staff believes that after these tasks are completed, a recommendation can be made in this matter.

**WHEREFORE**, the Staff respectfully submits this *Second Request for Extension of Time* to the Commission.
