On November 17, 2017, the Commission's Staff filed a *Partial Disposition Agreement and Request for Evidentiary Hearing*. The Commission finds that a procedural conference is now appropriate to discuss filing deadlines for a procedural schedule and a date for an evidentiary hearing. The parties or their representatives shall appear in person or by telephone at the conference, unless excused by the regulatory law judge. 1. A procedural conference shall be held on Friday, December 1, 2017, beginning at 9:00 a.m. in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This meeting will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. 
