Dear Secretary Woodruff:

X5 OpCo LLC (“X5 OpCo”) hereby submits this courtesy notification to the Missouri Public Service Commission (“Commission”) regarding the successful consummation of an Asset Purchase Agreement (“Agreement”) with NovaTel Ltd., Inc. (“NovaTel”), and of X5 OpCo’s initiation of interexchange telecommunications services in Missouri.

On November 9, 2015, NovaTel and X5 OpCo submitted a joint courtesy *Notification* informing the Commission that X5 OpCo was acquiring assets, including subscriber accounts, of NovaTel, through a mutually negotiated Agreement pending grant of X5 OpCo’s Certificate of Service Authority. On December 13, 2015, the Commission granted a Certificate of Service Authority to provide interexchange and non-switched local exchange telecommunications services in Missouri to X5 OpCo.¹

X5 OpCo now notifies the Commission of the successful consummation of the Agreement effective February 1, 2016.² Further, X5 OpCo notifies the Commission that with the transfer of NovaTel's assets to X5 OpCo, X5 OpCo initiated the provision of interexchange telecommunications services in Missouri beginning February 1, 2016, pursuant to the Company's Missouri Service Guide.³

NovaTel remains responsible for compliance with any pending regulatory obligations including submission of regulatory reports applicable to its operations prior to February 1, 2016. Contact information for X5 OpCo LLC remains unchanged.
