WWC License LLC d/b/a Cellular One Long Distance (WWC License) hereby submits this Application to the Missouri Public Service Commission pursuant to Section 392.410(5) and 4 CSR 240-2.060, to seek cancellation of: 1) its certificate of service authority to provide interexchange telecommunications services, and 2) its interexchange telecommunications tariff, P.S.C. MO. No. 1.

1. WWC License is a Delaware corporation with its principal offices and place of business located at 3650 131<sup>st</sup> Ave. SE, Suite 400, Bellevue Washington 98006. This Commission granted WWC License an interexchange certificate of service authority and approved its initial proposed Interexchange service tariff, Missouri P.S.C. No. 1, in Case No. TA-2001-131, Order issued December 1, 2000. A copy of required documentation from the Missouri Secretary of State was filed in TA-2001-131, remains accurate and is incorporated herein for all purposes pursuant to 4 CSR 240-2.060(1)(G). WWC License does not have any overdue PSC Annual Reports or assessments. In addition, WWC License states that there are no pending actions or final unsatisfied judgments or decisions against it in any state, federal agency, or court which involve customer service or rates. Applicant's Officer's Verification is attached hereto.

2. This cancellation will in no way impact the ongoing Commercial Mobile Radio Service (CMRS) that WWC License continues to provide to customers in Missouri pursuant to federal licenses.
