APPLICATION

COMES NOW Time Warner Cable Business LLC, ("Applicant"), a member-managed Delaware limited liability company, by its undersigned counsel, and files this verified application pursuant to 4 CSR 240-2.060, 4 CSR 240-3.510, Sections 392.410 to 392.455.1, RSMo, and the Federal Telecommunications Act of 1996, respectfully requesting that the Missouri Public Service Commission ("Commission") issue an order that:

- (a) grants Applicant a Certificate of Service Authority to provide interexchange telecommunications services pursuant to Section 392.410;
- (b) grants competitive status to Applicant, and classifies the Applicant's services as competitive, pursuant to Section 392.461; and
- (c) waives certain Commission rules and statutory provisions, pursuant to Section 392.420.

In support of its request, Applicant states as follows:

1. The legal name and principal office or place of business of the Applicant are:

- 2. A copy of Applicant's authority to transact business in Missouri is attached hereto as Exhibit A. The Applicant intends to do business under the fictitious name "Time Warner Cable," and attached hereto as Exhibit B is the registration of fictitious name filed with the Missouri Secretary of State.

- 4. Applicant is a competitive facilities-based provider of telecommunications services. Applicant proposes to provide high capacity non-voice transmission services to commercial customers within Missouri. Applicant seeks statewide authority to provide the proposed services.
- 5. Applicant possesses the technical and managerial expertise, as well as the financial resources, necessary to provide the proposed services. Applicant has experience in the telecommunications industry and the technical and financial resources to provide

Telecommunications services within Missouri. A description of the experience of the Applicant's management personnel is attached as **Exhibit C**.

- 6. Before providing the service for which authorization is sought by this Application, Applicant shall file and obtain Commission approval of a tariff incorporating the terms and conditions pursuant to which it will provide service.
- 7. Applicant requests classification as a competitive telecommunications company within the State of Missouri, and that its services be classified as competitive. Applicant believes that its proposed interexchange services will be subject to sufficient competition to justify a lesser degree of regulation. Granting of this application is in the public interest as it will allow greater price and service options for commercial customers.
- 8. Consistent with the Commission's treatment of other certificated interexchange telecommunications companies, Applicant requests waiver of the following statutes and regulations for Applicant and its interexchange services offerings:

- 9. The above-referenced rules and statutory provisions have been waived by the Commission for competitive interexchange carriers in prior cases. The rules and statutory provisions for which Applicant seeks waiver or exemption are principally applicable to non-competitive telecommunications carriers. It would be inconsistent with the provisions of Sections 392.361 to 392.520 and with the goal and purpose of Section 392.420 to apply such rules or statutory provisions to a competitive telecommunications carrier such as Applicant.
- 10. Pursuant to Section 386.570, Applicant will comply with all applicable Commission rules except those which are specifically waived by the Commission pursuant to a request filed

limited to, billing, quality of service, and tariff filing and maintenance in a manner

consistent with the Commission's requirements for interexchange carriers with whom

Applicant seeks authority to compete.

- 11. Applicant has no pending actions or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of this Application. No Commission annual reports or assessment fees are overdue.
- 12. Granting this Application will further the public interest by expanding the availability of competitive telecommunications services in the State of Missouri. In addition, intrastate offering of the services described in this Application is in the public interest because the services will provide Missouri customers with access to new technologies and service choices, and can permit customers to achieve increased efficiencies and cost savings. In particular, the public will benefit directly, through the use of the competitive services to be offered by Applicant, and indirectly, because the presence of Applicant in this market will increase the incentives for other telecommunications providers to operate more efficiently, offer more innovative services, reduce their prices, and improve their quality of service.

WHEREFORE, Applicant Time Warner Cable Business LLC, respectfully requests that the Missouri Public Service Commission grant it a certificate of service authority to provide interexchange telecommunications services within the State of Missouri. Applicant also requests
