SECOND AMENDED APPLICATION

Dial-Around Telecom, Inc., by Hendren and Andrae, LLC,
Richard S. Brownlee, III, and files this verified application
pursuant to 4 CSR 240-2.060 and 4 CSR 240-3.510, and respectfully
requests that the Missouri Service Commission ("Commission") issue
an order that:

(a) Grants Applicant a Certificate of Service Authority to
provide Interexchange telecommunications resale services,
including related operator services, pursuant to Chapter 392 of
the Missouri Revised Statutes and Commission Rules.

(b) Grants competitive status to Applicant.

(c) Waives certain Commission rules and statutory provisions
pursuant to Section 392.420, RSMo Cumm. Supp. 1992.

In support of its request, Applicant states:

1. In it's First Amended Application, Applicant
inadvertently included a request for waiver of 4 CSR
240.3.550(5)(c) which did not apply to interexchange
telecommunications carriers such as applicant. The purpose of

this Second Amended Application is to remove the request for waiver of that regulation.

2. Dial-Around Telecom, Inc. is a Florida Corporation which was certified to transact business in the State of Florida on September 17, 2002. A copy of Applicant's Certificate of Authority to transact business in the State of Missouri as a foreign corporation is attached hereto as **Exhibit A**

4. Applicant proposes to provide the following interexchange telecommunications services throughout the State of Missouri:

- * 1+ Residential Equal Access
- * 1+ Business Equal Access
- * 800 Service
- * Travel Card Service
- * Debit Card Service
- * Alternate Operator Services

Dial-Around Telecom, Inc. intends to provide telecommunications services as a non-facilities based reseller of

the Interexchange Services utilizing its own switches and underlying carrier's network facilities. The customer will become a customer of applicant, not the underlying carrier. Dial-Around Telecom, Inc. agrees not to block access to any customer or to any other long distance provider or local exchange carrier.

Dial-Around Telecom, Inc. will assume responsibility for billing, trouble reporting, and customer service on the services

Dial-Around Telecom, Inc. bills directly. The operator services and residential services will be billed by a third party billing entity who has billing and collection agreements with the LEC's will handle billing, trouble reporting to Dial-Around Telecom, Inc., and initial customer service. All customer service issues that the third party billing entity can not resolve will be sent to Dial-Around Telecom, Inc. to handle directly with the customer.

5. Applicant has the experience in the telecommunications industry and the technical and financial resources to provide telecommunications services within Missouri.

7. Applicant will file its tariff for approval prior to the granting of the authority sort herein, and hereby request waiver of 4 CSR 240-3.510(1)(C).

8. Applicant request classification as a competitive telecommunications company within the State of Missouri. Applicant believes that its proposed services will be subject to sufficient competition to justify a lesser degree regulation. Granting of the application will allow greater price and service options to telephone users.

9. Applicant also requests, pursuant to Section 392.420, RSMo (Cumm.Supp.1992), that the Commission waive the application of the following rules and statutory provisions as it relates to the regulation of Applicant.

The above-referenced rules and statutory provisions have been waived to other interexchange carriers in prior cases. Dial-Around Telecom, Inc. requests waiver of same for the following reasons: It is a non-facilities-based reseller of Interexchange telecommunications services. It is not regulated by the PSC as a monopoly service provider. It relies on the competitive marketplace to determine acceptable terms and rates for the various competitive telecommunications services offered by the company.

10. Applicant has no pending actions or final, unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of the application.

11. No annual report or assessment reports are overdue.

12. Applicant pursuant to Section 386.570 RSMo, will comply with all applicable Commission Rules except those which are specifically waived by the Commission pursuant to a request filed by the Applicant.


