### **ORDER APPROVING TARIFFS IN COMPLIANCE**

Issue Date: November 13, 2007

Effective Date: November 19, 2007

On July 13, 2007, Missouri-American Water Company (MAWC) filed applications with the Missouri Public Service Commission, pursuant to Section 393.170, RSMo 2000, requesting that the Commission grant it authority to provide water service and sewer service to an unincorporated portion of Warren County, Missouri. Separate cases were opened to consider certification of the water and sewer systems. Finding that the issues in the water certification case, Case No. WA-2008-0012, were clearly related to those in the sewer certification case, Case No. SA-2008-0019, the Commission issued an order dated July 18, 2007, consolidating these two cases and designated Case No. WA-2008-0012 as the lead case.

On October 11, the Commission granted the certificates. In the Commission's Order Granting Certificate of Public Convenience and Necessity ("Order"), the Commission directed MAWC to submit revised tariff sheets for its Incline Village water and sewer tariffs to include a map and written description of the revised service area in each.

On October 19, MAWC filed its revised tariff sheets, YW-2008-0247 and YW-2008-0248, bearing an effective date of November 19. On October 26, MAWC filed

substitute revisions of the tariff sheets originally filed in YW-2008-0247 and YS-2008-0248, in YW-2008-0248. MAWC also filed two additional sets of revised tariff sheets, YW-2008-0271 and SW-2008-0272, bearing an effective date of November 26.

On November 8, 2007, the Staff of the Missouri Public Service Commission filed its recommendation and verified memorandum. Staff finds the revised tariff sheets, as substituted, to be in compliance with the Commission's Order and recommends that the Commission approve the submitted tariffs, as substituted, to become effective no later than November 19, 2007. Staff also advised the Commission that Tariff File No. YW-2008-0247 is now obsolete because substitute tariff sheets have been submitted elsewhere, and the version of PSC MO No. 7, 1<sup>st</sup> Revised Sheet No. 2, contained therein should be rejected.

Also on November 8, 2007, the Office of the Public Counsel filed a pleading advising the Commission that it did not object to the Commission rejecting the tariff sheets contained in Tariff File No. YW-2008-0247 or approving the remaining submitted tariffs, as substituted.

The Commission has reviewed the tariff filings, Staff's verified recommendation and memorandum, and Public Counsel's response, which are hereby admitted into evidence, and finds that MAWC's tariffs assigned Tariff File Nos. YW-2008-0248, YW-2008-0271 and YS-2008-0272, as substituted, should be approved. The Commission also agrees that Tariff File No. YW-2008-0247 is obsolete, because MAWC submitted substitutes for the water tariff sheets originally filed in Tariff File No. YW-2008-0247 in Tariff File No. YW-2008-0248. Accordingly, the version of PSC MO No. 7, 1<sup>st</sup> Revised Sheet No. 2, contained in Tariff File No. YW-2008-0247 shall be rejected.

**IT IS ORDERED THAT:**

1. The **water service** tariff sheet filed by Missouri-American Water Company on October 19, 2007, and assigned Tariff No. YW-2008-0247, is rejected. The tariff sheet rejected is:
