APPLICATION FOR APPROVAL OF AMENDMENT TO INTERCONNECTION AGREEMENT

COMES NOW YourTel America, Inc. ("YourTel" or "Applicant"), and hereby files this Application for Approval of an Amendment to the Interconnection Agreement (the "Agreement") between YourTel and Southwestern Bell Telephone, L.P. d/b/a AT&T Missouri ("AT&T"), under the Telecommunications Act of 1996, Public Law No. 104-104 ("Federal Act"), and 4 CSR 240-3.513, stating the following:

A. PRELIMINARY MATTERS

1. YourTel is a competitive local exchange carrier ("CLEC") in Missouri. In Case No. TA-99-115, the Commission granted The Pager Company certificate of service authority to provide basic local and local exchange telecommunications services. In Case No. TO-2002-165, the Commission acknowledged the addition of a fictitious name, i.e., The Pager Company d/b/a The Pager & Phone Company. On December 15, 2006, The Pager Company d/b/a The Pager & Phone Company filed adoption notices and revised tariff title sheets, with a proposed effective date of January 17, 2007, to reflect its change of corporate name to YourTel America, Inc. in Case No. CN-2007-0218. The Commission recognized YourTel's name change by Order dated January 3, 2007. YourTel's office and principal place of business are located at 2800 E. 18th St., Kansas City, Missouri.

- 2. By this Application, YourTel seeks Commission approval of an Amendment to Interconnection Agreement between YourTel and AT&T. The original Interconnection Agreement was approved by the Commission in Case No. TK-2006-0048. YourTel adopted this interconnection agreement and the Commission indicated that this adoption was effective on August 29, 2005 (tracking no. VT-2008-0014). AT&T's office and principal place of business is located at One SBC Center, Room 3520, St. Louis, Missouri 63101. AT&T is a "local exchange telecommunications company" and a "public utility," and is duly authorized to provide "telecommunications service" within the State of Missouri as each of those phrases are defined in Section 386.020, RSMo. 2000.
- 3. YourTel is a Missouri corporation and its Certificate of Good Standing is attached as Exhibit A.

B. AMENDMENT TO INTERCONNECTION AGREEMENT REACHED

5. YourTel presents to this Commission for approval an Amendment to an Interconnection Agreement negotiated, executed, and approved pursuant to the terms of the Federal Act. After comprehensive, good faith negotiations, YourTel and AT&T executed the Amendment on January 28, 2008. The Amendment is appended hereto.

C. REQUEST FOR APPROVAL

- 6. YourTel seeks the Commission's approval of the Amendment, consistent with the provisions of the Federal Act and Missouri law. YourTel believes that the implementation of this Amendment complies fully with Section 252(e) of the Telecommunications Act of 1996 because the Amendment is consistent with the public interest, convenience and necessity, and does not discriminate against any telecommunications carrier. The Amendment promotes diversity in providers, provides interconnectivity, and increases customer choices for telecommunications services.
- 7. YourTel respectfully requests that the Commission grant expeditious approval of this Amendment, without change, suspension or other delay in its implementation. This is a bilateral Amendment, reached as a result of negotiations and compromise between competitors, and intervention by other parties is neither necessary nor appropriate.

D. STANDARD FOR REVIEW

- 8. The statutory standards of review are set forth in Section 252(e) of the Telecommunications Act of 1996 which provides as follows:
 - (1) APPROVAL REQUIRED.--Any interconnection agreement adopted by negotiation or arbitration shall be submitted for approval to the State commission. A State commission to which an agreement is submitted shall approve or reject the agreement, with written findings as to any deficiencies.
 - (2) GROUNDS FOR REJECTION.--The State commission may only reject --
 - (A) an agreement (or any portion thereof) adopted by negotiation under subsection (a) if it finds that --
 - (i) the agreement (or portion thereof) discriminates against a telecommunications carrier not a party to the agreement; or

(ii) the implementation of such agreement or portion is not consistent with the public interest, convenience, and necessity; . . .

9. The Agreement fully complies with the criteria applicable for approval, and does

not violate any of the criteria to be applied for rejection. Thus, the Amendment should be

approved.

10. YourTel does not have any pending action or final unsatisfied judgments or

unsatisfied judgments or adverse decisions from any state or federal agency or court which

involve customer service or rates, which action, judgment, or decision has occurred within three

years of the date of this Application.

11. YourTel does not have any annual report or assessments which are overdue.

E. CONCLUSION

WHEREFORE, YourTel respectfully requests that the Commission approve the attached

Amendment to the Interconnection Agreement between YourTel and AT&T.

AMENDMENT TO INTERCONNECTION AGREEMENT UNDER SECTIONS 251 AND 252 OF THE TELECOMMUNICATIONS ACT OF 1996 BETWEEN SOUTHWESTERN BELL TELEPHONE COMPANY d/b/a AT&T MISSOURI AND YOURTEL AMERICA, INC.

The Interconnection Agreement dated August 19, 2005 by and between Southwestern Bell Telephone Company d/b/a AT&T Missouri ("AT&T")¹ and YourTel America, Inc. (f/k/a The Pager Company d/b/a The Pager & Phone Company) ("YourTel") ("Agreement") effective in the State of Missouri is hereby amended as follows:

- Section 4.0 Effective Date and Term of Agreement of the General Terms and Conditions is amended by adding the following section:
 - 4.2.2 Notwithstanding anything to the contrary in this Section 4.0, the original expiration date of this Agreement, as modified by this Amendment, will be extended for a period of three (3) years from November 10, 2008 until November 10, 2011 (the "Extended Expiration Date"). The Agreement shall expire on the Extended Expiration Date; provided, however, that during the period from the effective date of this Amendment until the Extended Expiration Date, the Agreement may be terminated earlier either by written notice from YourTel, by AT&T Missouri pursuant to the Agreement's early termination provisions, by mutual agreement of the parties, or upon the effective date of a written and signed superseding agreement between the parties.
- 2. The Parties acknowledge and agree that AT&T Missouri shall permit the extension of this Agreement, subject to amendment to reflect future changes of law as and when they may arise.
- 3. EXCEPT AS MODIFIED HEREIN, ALL OTHER TERMS AND CONDITIONS OF THE UNDERLYING AGREEMENT SHALL REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
- 4. In entering into this Amendment, neither Party waives, and each Party expressly reserves, any rights, remedies or arguments it may have at law or under the intervening law or regulatory change provisions in the underlying Agreement (including intervening law rights asserted by either Party via written notice predating this Amendment) with respect to any orders, decisions, legislation or proceedings and any remands thereof, which the Parties have not yet fully incorporated into this Agreement or which may be the subject of further review.
- 5. This Amendment shall be filed with and is subject to approval by the Missouri Public Service Commission and shall become effective ten (10) days following approval by such Commission.

¹ On December 30, 2001, Southwestern Bell Telephone Company (a Missouri corporation) was merged with and into Southwestern Bell Texas, Inc. (a Texas corporation) and, pursuant to Texas law, was converted to Southwestern Bell Telephone, L.P., a Texas limited partnership. On June 29, 2007, Southwestern Bell Telephone, L.P., a Texas limited partnership, was merged with and into SWBT Inc., a Missouri corporation, with SWBT Inc. as the survivor entity. Simultaneous with the merger, SWBT Inc. changed its name to Southwestern Bell Telephone Company. Southwestern Bell Telephone Company is doing business in Missouri as "AT&T Missouri".
