## MOTION TO OPEN CASE AND CANCEL CERTIFICATE OF SERVICE AUTHORITY AND ACCOMPANYING TARIFF

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and moves that the Commission open a case and cancel Areocom LLC's certificate of service authority to provide interexchange and nonswitched local exchange telecommunications services, restricted to providing dedicated private line services, as well as its tariff. In support of its Motion, Staff respectfully states as follows:

- 1. On July 26, 2003, the Missouri Public Service Commission (Commission) granted a certificate of service authority to provide interexchange and nonswitched local exchange telecommunications services, restricted to providing dedicated private line services, to Areocom LLC, in Case No. XA-2003-0548. The Commission also approved Areocom LLC's tariff, PSC Mo-No. 2.
- 2. Areocom, LLC has indicated in its confidential Statement of Revenue it submitted to the Commission that it is no longer in business. In that document, the company's representative indicated that it was reporting no Missouri jurisdictional revenue and that it no longer wished to maintain its operating certificate in Missouri. The notarized statement of revenue containing this statement was submitted to the Commission by the president of the company and is available on a highly confidential basis from the Commission's Electronic Filing and Information System.

- 3. Areocom, LLC has no past due annual reports or assessments to the Commission.

  No formal complaints have been filed against the company since the commencement of the Electronic Filing and Information System.
- 4. Areocom, LLC is a Missouri limited liability corporation that has submitted its Articles of Termination for Limited Liability Company to the Missouri Secretary of State and accordingly, its existence has ceased. (See Appendix A).
- 5. Because Areocom, LLC has requested cancellation of its certificate and because it is not providing telecommunications service in Missouri, the Staff recommends that the Commission issue an order canceling Areocom, LLC's certificate and tariff.
- 6. The Commission has the authority to cancel a telecommunications corporation certificate pursuant to Section 392.410.5 RSMo (Supp. 2005), which provides:

"Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. <u>State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission</u>, 776 S.W.2d 494 (Mo. App. 1989).

7. This pleading is being served on the address provided by the company to the Commission via certified mail, as well as upon its Missouri registered agent.

WHEREFORE, the Staff recommends the Commission cancel the certificate of service authority of Areocom, LLC to provide interexchange and nonswitched local exchange telecommunications services, restricted to providing dedicated private line services, and the accompanying tariff, P.S.C. Mo.-No. 2.


