ORDER CANCELING CERTIFICATE
AND ACCOMPANYING TARIFF

Issue Date: April 19, 2006

Effective Date: April 29, 2006

On April 14, 2006, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariff of Areocom LLC, a company that has been authorized by the Commission to offer interexchange and non-switched exchange telecommunications services, restricted to providing dedicated private line services.

In Case Number XA-2003-0548, the Commission granted Areocom a certificate to provide interexchange and non-switched exchange telecommunications services, restricted to providing dedicated private line services. The Commission also approved Areocom's tariff, PSC Mo No. 2.

Staff's motion states that Areocom indicated in its confidential Statement of Revenue that it is no longer in business. Furthermore, Areocom informed Staff it had no Missouri jurisdictional revenue and no longer wished to maintain its operating certificate in Missouri. Areocom also submitted its Articles of

Termination for Limited Liability Company to the Missouri Secretary of State's office, and its existence in the state of Missouri has ceased. Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff, PSC Mo No. 2, to provide interexchange and non-switched exchange telecommunications services, restricted to providing dedicated private line services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and Areocom's request to cancel the certificate and tariff included in its Statement of Revenue, the Commission finds that the certificate of service authority and accompanying tariff granted to Areocom LLC, shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide interexchange and non-switched exchange telecommunications services, restricted to providing dedicated private line services granted to Areocom LLC, in Case Number XA-2003-0548 is canceled.
2. Areocom LLC's tariff, PSC Mo No. 2, is canceled.
3. This order shall become effective on April 29, 2006.

4. This case may be closed on April 30, 2006.
