**ORDER GRANTING LEAVE TO APPEAR**

This order grants Lance J.M. Steinhart leave to appear as counsel for Telcentrex, LLC ("Telcentrex") in this matter.

On January 2, 2007, Lance J.M. Steinhart filed an Entry of Appearance as counsel on behalf of Telcentrex in this matter. Because Mr. Steinhart is not admitted to the Missouri Bar, the Commission will treat this document as a request for leave to appear and participate in this case as a visiting attorney under Commission Rule 4 CSR 240-2.040(3)(C).

The Entry of Appearance indicates that Mr. Steinhart is a member in good standing of the State Bar of Georgia, and that neither he nor any member of his law firm has been disqualified to appear in any court. Simultaneous with Mr. Steinhart's entry of appearance, Judith A. Rau, who is a member of the Missouri Bar, also entered her appearance for Telcentrex in this case. Mr. Steinhart has designated Ms. Rau to serve as associate counsel for purposes of this case.

Mr. Steinhart has also submitted a December 22, 2006 letter from the Clerk of the Missouri Supreme Court showing Mr. Steinhart's compliance with Missouri Supreme Court Rule 6.01(m) with regard to this case.

The Commission finds that Mr. Steinhart has substantially complied with Commission Rule 4 CSR 240-2.040(3)(C) and Missouri Supreme Court Rule 6.01(m). Accordingly, his request for leave to appear and participate in this case on behalf of Telcentrex as a visiting attorney is granted.

**IT IS ORDERED THAT:**

1. Lance J.M. Steinhart's request for leave to appear and participate in Case No. XA-2007-0252 as a visiting attorney under Commission Rule 4 CSR 240-2.040(3)(C) is granted.

2. This order shall become effective on January 5, 2007.
