

FIRST AMENDED APPLICATION

COMES NOW Fox Communications Corporation ("Fox" or "Applicant"), pursuant to 4 CSR 240-2.080(20), and requests that its Application filed on June 11, 2003, be amended by interlineations on pages 3-4, at paragraph 12 to read as follows:

"12. Applicant also respectfully requests, pursuant to Section 392.420, that the Commission suspend, waive, or modify the application of the following rules and statutory provisions as they relate to the regulation of the Applicant:

4 CSR 240-10.020	-	Depreciation and income
4 CSR 240-3.545(2)(C)	-	Posting of exchange rates at central operating offices
4 CSR 240-30.040	-	Uniform system of accounts
4 CSR 240-33.030	-	Minimum charge rules
Section 392.210.2	-	Establish uniform system of accounts for annual reports
Section 392.240(1)	-	Rates – reasonable average return on investment
Section 392.270	-	Property valuation
Section 392.280	-	Depreciation rates
Section 392.290	-	Issuance of securities
Section 392.300.2	-	Acquisition of stock
Section 392.310	-	Issuance of stocks and debt
Section 392.320	-	Stock dividend payment
Section 392.330	-	Issuance of securities, debt, and notes
Section 392.340	-	Reorganization(s)

The above-referenced rules and statutory provisions have been waived with regard to other interexchange carriers in prior cases. These rules or statutory provisions are principally designed to apply to non-competitive telecommunications carriers. It would be inconsistent with the goal and purpose of Section 392.530 to apply them to a competitive telecommunications carrier such as the Applicant."

2. The purpose of this amendment is to amend the citation in paragraph 12, from "4 CSR 240-30.010(2)(C)" to "4 CSR 240-3.545(2)(C)" to reflect the recent adoption of the Commission's new Chapter 3 which now supercedes the provision related to the posting of exchange rates at central operating offices previously contained in 4 CSR 240-30.010(2)(C).

WHEREFORE, Applicant Fox Communications Corporation respectfully requests the Missouri Public Service Commission to grant it a Certificate of Service Authority to provide competitive intrastate interexchange telecommunications services within the state of Missouri; an order classifying it as a competitive telecommunications company providing competitive service; an order suspending, waiving, or modifying the above-referenced rules and statutory provisions as they relate to the regulation of the Applicant in the state of Missouri; and for such further orders as the Commission deems appropriate.


