
Reference is made to your letter of June 25, 2004 regarding an annual assessment for 2004, a copy of which is attached.

Please be advised that (1) pursuant to previous telephone and written correspondence with Helen Davis in your office, the Company has relinquished its certification as an interexchange telecommunications carrier to provide telecommunications services in Missouri; (2) in connection with this relinquishment and pursuant to correspondence from the Missouri Department of Revenue dated March 29, 2004, the Department confirmed that the Company had no delinquencies or outstanding obligations regarding filing of required franchise tax reports or related payments; (3) pursuant to a certificate of withdrawal issued by the Missouri Secretary of State dated April 19, 2004, the Company has withdrawn from Missouri; (4) the Company did not conduct business in Missouri during calendar year 2003; and (5) the Company ceased doing business in all jurisdictions during calendar year 2003 and is no longer an operating concern.

Accordingly, please adjust your records to show that no amounts are due and owing by the Company in Missouri. I'd appreciate your confirmation of this at your convenience.

The Company was not active in Missouri during calendar year 2000 and has no revenues to report, as noted on the Statement of Revenue.


With the enclosed payment, I understand that we are current on all assessment requirements. Please let me know if that is not correct.
