MOTION TO OPEN CASE AND CANCEL CERTIFICATE OF SERVICE AUTHORITY AND ACCOMPANYING TARIFF

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and moves that the Commission open a case and cancel Communications Billing, Inc.'s certificate of service authority to provide interexchange telecommunications services and its tariff. In support of its Motion, Staff respectfully states as follows:

1. In September 1998, the Commission granted Communications Billing, Inc. a certificate of service authority to provide intrastate interexchange telecommunications services in Missouri in Case No. TA-99-29. The Commission approved the company's tariff, Missouri P.S.C. Tariff No. 1, in the same case.

2. The web site of the Office of the Missouri Secretary of State reports that the certificate of authority granted to Communications Billing, Inc., an Ohio corporation, was revoked November 4, 2004 because the company failed to file its Annual Registration Report. Section 351.602.3 RSMo. (2000) states that "[t]he authority of a foreign corporation to transact business in this state ceases on the date shown on the certificate revoking its certificate of authority."

3. The telephone number provided to the Commission by the company is no longer in service. A second number found in the 2003 annual report remains operational. Messages left

at that number are not returned, however. Mail has not been returned when sent to the address provided to the Commission by the company, however.

4. Communications Billing, Inc. owes no assessments. The company has failed to submit its 2004 annual report, but had complied previously. Staff counsel contacted the former regulatory representative for Communications Billing, Inc. at Telecom Compliance Services that completed the 2003 annual report, who indicated that they were unaware of any other way to contact their former client.

5. Staff believes that Communications Billing, Inc., has violated the terms of its certificate by its failure to keep the Commission informed of its current telephone number or provide current contact information through the annual report process. The company's former regulatory representative also has indicated they have no way to contact the company. Section 392.210(2) RSMo. (2000) states, among other things, "The commission shall at all times have access to all accounts, records and memoranda kept by telecommunications companies... ." Because Communications Billing, Inc., has failed to keep the Commission informed of a current address or telephone number, the Commission is unable to contact Communications Billing, Inc., Therefore, Communications Billing, Inc., has denied the Commission access that is required of the Commission under Section 392.210(2) RSMo. (2000). Certainly, Communications Billing, Inc., has denied the Commission access that is required of the Commission its ability to supervise telecommunications operations and services as statutorily mandated under Section 386.250 RSMo. (2000).

6. No customers have contacted the Commission with complaints about Communications Billing, Inc., since the commencement of the Commission's EFIS system.

7. The Commission has the authority to cancel a telecommunications corporation certificate pursuant to Section 392.410.5 RSMo (Supp. 2004), which provides:

Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. 1989).

8. Thus, the Commission has the authority to cancel the certificate of service authority it granted to Communications Billing, Inc., to provide intrastate interexchange telecommunications services in Missouri in Case No. TA-99-29, as well as the company's tariff, Missouri P.S.C. Tariff No. 1. Such an action is supported because the company appears to have disappeared and the Commission's Staff is unable to communicate with the company other than by sending letters that do not generate a response.

9. This pleading is being served via certified mail upon the most recent address provided to the Commission by the company. It is also being served by regular mail upon its registered agent.

WHEREFORE, the Staff recommends the Commission cancel the certificate of service authority it granted to Communications Billing, Inc., to provide intrastate interexchange telecommunications services in Missouri in Case No. TA-99-29, as well as the company's tariff, Missouri P.S.C. Tariff No. 1.
