ORDER CANCELLING CERTIFICATE AND TARIFF AND CLOSING CASE

Issue Date: August 2, 2005 Effective Date: August 12, 2005

This order cancels the certificate of service authority and tariffs of CRG International, Inc., doing business as Network One.

On July 14, 2005, the Staff of the Missouri Public Service Commission moved to cancel the certificate of service authority and tariffs of CRG International, Inc., doing business as Network One. In support thereof, Staff states that this Commission granted CRG, a Georgia corporation, a certificate of service authority to provide interexchange telecommunications services in February 1998, in Case No. TA-98-226. In the same case, the Commission approved CRG's first tariff, P.S.C. Mo. Tariff No. 1. Later, the Commission approved a second tariff for CRG, P.S.C. Mo. Tariff No. 2.

Staff further states that in April 2002, CRG filed a petition in the United States District Court for the Northern District of Georgia under Chapter 7 of Title 11 of the United States Code, providing for bankruptcy. On July 13, 2005, the United States Trustee advised Staff that CRG's certificate could be cancelled. Staff further states that the web site of the Office of the Missouri Secretary of State reports that the certificate of authority granted to CRG was withdrawn on June 29, 2000. Section 351.602.3, RSMo 2000, states

that "[t]he authority of a foreign corporation to transact business in this state ceases on the date shown on the certificate revoking its certificate of authority." Staff also states that CRG's mail has been returned by the post office as undeliverable. The mail had been sent to the address provided to the Commission by the company. According to the Commission's records, CRG has not submitted an annual report to this Commission since Calendar Year 2000. Staff states that CRG does not owe any Commission assessments.

Staff urges the Commission to cancel CRG's certificate and tariffs because it has ceased operations and is being liquidated.

The Commission finds that CRG has ceased operations and is being liquidated and that its certificate and tariffs should therefore be cancelled.

IT IS THEREFORE ORDERED:

- That the Motion to Open Case and Cancel Certificate of Service Authority and Tariffs, filed on July 14, 2005, by the Staff of the Missouri Public Service Commission, is granted.
- 2. That the certificate of service authority granted to CRG International, Inc., doing business as Network One, in February 1998, in Case No. TA-98-226, is cancelled.
- 3. That the tariffs of CRG International, Inc., doing business as Network One, are cancelled.

- 4. That this order shall become effective on August 12, 2005.
- 5. That this case may be closed on August 13, 2005.
