**ORDER CANCELING CERTIFICATE**  
**AND ACCOMPANYING TARIFF**

Issue Date: July 20, 2006

Effective Date: July 30, 2006

On June 15, 2006, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and accompanying tariff of PT-1 Communications, Inc., a company that has been authorized to offer intrastate interexchange telecommunications services by the Commission.

In Case Number TA-97-470, the Commission granted PhoneTime, Inc., a certificate to provide intrastate interexchange telecommunications services. In Case Number TO-98-400, PhoneTime, Inc., changed its name to PT-1 Communications, Inc. The company's tariff, Mo. PSC Tariff No. 1, was also approved.

Staff's motion states PT-1 Communications is in good standing with the Missouri Secretary of State's Office; however, the company failed to file its 2005 Annual Registration Report. The Missouri Secretary of State notified PT-1

Communications that their authority to do business in Missouri would be revoked if the company failed to submit its report.

Staff's attempts to contact PT-1 Communications via mail and telephone were unsuccessful. The Commission's contact information is the same information on record with the Secretary of State's Office. Staff served copies of their motion upon the company at the address on file with the Commission, as well as the company's registered agent via certified mail.

PT-1 Communications failed to file a 2005 Annual Report with the Commission. PT-1 Communications owes no assessments to the Commission. Past annual reports indicate the company has no Missouri jurisdictional revenue and no Missouri customers. In addition, no complaints have been filed against the company since the commencement of the Electronic Filing and Information System.

Section 392.210(2) RSMo 2000, requires the company keep the Commission informed of the company's current address and contact information. PT-1 Communications failed to do so. Therefore, PT-1 Communications has denied the Commission its ability to supervise the company's telephone operations and services as mandated by Section 386.250 RSMo. Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff, Mo. PSC Tariff No. 1, to provide intrastate interexchange telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or

service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

PT-1 Communications has not responded to Staff’s motion.

Because PT-1 Communications failed to keep the Commission informed of its current address and contact information, the Commission was denied the ability to supervise the company’s operations and services. Because of that failure, and because the company does not provide telecommunication services in Missouri, the Commission finds that the certificate of service authority and accompanying tariff granted to PT-1 Communications, Inc., shall be canceled.

**IT IS ORDERED THAT:**

1. The certificate of authority to provide intrastate interexchange telecommunications services granted to PT-1 Communications, Inc., in Case Number TA-97-470, is canceled.
2. PT-1 Communications’s tariff, Mo. PSC Tariff No. 1, is canceled.
3. This order shall become effective on July 30, 2006.

4. This case may be closed on July 31, 2006.
