#### STAFF RECOMMENDATION

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and for its Staff Recommendation states as follows:

- 1. On July 23, 2009, Friendship Village of West County (Friendship Village or the Company) filed with the Missouri Public Service Commission (the Commission) a letter requesting that its "Competitive Interexchange Telecommunications Carrier Certificate and corresponding Tariff be cancelled immediately." The July 23, 2009 letter expressed Friendship Village's desire to maintain its Shared Tenant Services Carrier Certificate. This case has been designated by the Commission as Case No. XD-2010-0034.
- 2. On July 24, 2009, the Commission issued its <u>Order Directing Staff to File a Recommendation</u>, ordering to Staff to file a recommendation in this matter no later than August 3, 2009.
- 3. In Case No. TA-97-353 the Commission granted Friendship Village a certificate of service authority to provide Shared Tenant Services (STS). In Case No. TA-98-490 the Commission granted Friendship Village a certificate of service authority to provide intrastate interexchange telecommunications services, granted the Company competitive status, and approved the Company's initial interexchange tariff, P.S.C. MO. No. 1.

4. The Commission has the authority to cancel a telecommunications corporation's certificate of service authority pursuant to Section 392.410.5 RSMo (Supp. 2008), which provides:

Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo.App. 1989).

- 5. In the attached document, labeled Appendix A, Staff states that cancellation of the certificate of service authority to provide intrastate interexchange telecommunications service and the accompanying interexchange tariff of Friendship Village is not detrimental to the public interest and that Staff has no objection to the requested cancellation. The cancellation of the certificate and the accompanying tariff will have no impact upon the Company's STS certificate.
- 6. Friendship Village is not delinquent in the submission of its annual reports or in the payment of its Commission assessments or Relay Missouri and MoUSF surcharges.

**WHEREFORE**, Staff recommends the Commission issue an order cancelling Friendship Village's certificate of service authority to provide intrastate interexchange telecommunications service, as well as its accompanying tariff, P.S.C. MO. No. 1.
