### ORDER DIRECTING NOTICE

On January 7, 2010, the Staff of the Missouri Public Service Commission filed a motion requesting the Commission to cancel 1-800-RECONEX, Inc.'s certificate of service authority to provide intrastate interexchange and nonswitched local exchange telecommunications service in the state of Missouri and its accompanying tariff. By order issued February 22, 2001, in File No. TA-2001-389, the Commission granted RECONEX a certificate of service authority to provide interexchange and nonswitched local exchange telecommunications service and approved RECONEX's tariff, PSC Mo. Tariff No. 2.

The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed ten days from the issuance of this order to file a motion for hearing.

### THE COMMISSION ORDERS THAT:

1. Any party wishing to file an objection or request a hearing shall do so by filing a pleading no later than January 19, 2010, with:
