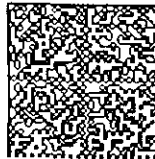

**ORDER CANCELING CERTIFICATE AND
ACCOMPANYING TARIFF**

Issue Date: January 22, 2010

Effective Date: February 1, 2010

On January 7, 2010, the Staff of the Missouri Public Service Commission filed a motion requesting the Commission to cancel 1-800-RECONEX, Inc.'s certificate of service authority to provide intrastate interexchange and nonswitched local exchange telecommunications services in the state of Missouri and its accompanying tariff. In File No. TA-2001-389, the Commission granted RECONEX a certificate to provide interexchange and nonswitched local exchange telecommunications service. The company's tariff, PSC Mo. Tariff No. 2, was also approved.

RECONEX is an Oregon corporation previously registered with the Missouri Secretary of State; however, according to the Secretary of State's office, RECONEX failed to renew its fictitious name registration by the due date and thus stands expired. Staff states that it has been unable to contact RECONEX and that RECONEX is delinquent in paying its assessment to the Missouri Public Service Commission. For these reasons, and because RECONEX may no longer lawfully conduct business in Missouri, Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff.

On January 7, 2010, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than January 19, 2010. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority granted to 1-800-RECONEX, Inc., and the accompanying tariff, shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide intrastate interexchange and nonswitched local exchange telecommunications services granted to 1-800-RECONEX, Inc., in File No. TA-2001-389, is canceled.
2. 1-800-RECONEX, Inc.'s tariff, PSC Mo. Tariff No. 2, is canceled.
3. This order shall become effective on February 1, 2010.
4. This case may be closed on February 2, 2010.
