## ORDER DIRECTING NOTICE

On February 25, 2010, the Staff of the Missouri Public Service Commission filed a request asking the Commission to cancel 1-800-RECONEX, Inc.'s certificate of service authority to provide basic local exchange telecommunications service in the state of Missouri and its accompanying tariffs. By order issued March 18, 1999, in File No. TO-99-177, the Commission granted RECONEX a certificate of service authority to provide basic local telecommunications service and approved RECONEX's tariffs, PSC Mo. Tariffs No. 1 and 3.

The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, if no request for a hearing or objection to Staff's request is received, the Commission may cancel the certificate based on Staff's request.

The Commission finds that proper persons shall be allowed ten days from the issuance of this order to file a motion for hearing.

**THE COMMISSION ORDERS THAT:**

1. Any party wishing to file an objection or request a hearing shall do so by filing a pleading no later than March 8, 2010, with:


