**MOTION TO CANCEL CERTIFICATES OF SERVICE AUTHORITY  
AND ASSOCIATED TARIFF**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through the undersigned counsel, and moves for the Missouri Public Service Commission ("Commission") to cancel the certificates of service authority and associated tariff of United American Technology, Inc. ("United American Technology" or "Company"). For its Motion, Staff respectfully states as follows:

1. On April 26, 2007, the Commission granted certificates of service authority to United American Technology to provide interexchange and non-switched local exchange telecommunications service in the State of Missouri in Case No. XA-2007-0337 and approved the tariff assigned tracking number JX-2007-0783.

2. The Commission's Order granting United American Technology its certificate reminded the Company of its obligation to file an annual report pursuant to Section 392.210, RSMo.

3. Section 392.210.1 RSMo (2000) requires every telecommunications company to "...file with the commission an annual report at a time and covering the yearly period fixed by the commission," and Rule 4 CSR 240-3.540(1) requires the report to be filed on or before April 15<sup>th</sup> of each year.

4. At the time of this filing, the Company has not submitted its calendar year 2012 annual report.

5. Despite Staff's attempt to contact United American Technology, the Company has continued to be delinquent in the filing of its calendar year 2012 annual report.

6. Due to the Company's continued neglect of the Commission's statutes, rules and orders, Staff moves for the Commission to cancel United American Technology's certificate of service authority and associated tariff.

7. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

8. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. W.D. 1989).

9. If the Commission cancels United American Technology's certificate of service authority, the Staff also recommends the Commission order the Company to provide notice to the Commission when transfer of its customers to another provider is complete.

**WHEREFORE**, Staff recommends the Commission give notice to United American Technology, Inc., as required by law and, after the opportunity for hearing, cancel its certificates of service authority and associated tariff to provide interexchange and non-switched local exchange telecommunications service in the State of Missouri. Staff further requests that the Commission require the Company to notify the Commission when transfer of customers to another provider is complete.
