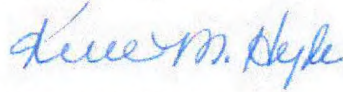
The Company believes that prior Commission approval of this name change is not required and, as such, will begin conducting business within the State of Missouri under the name Zang, Inc. effective immediately.

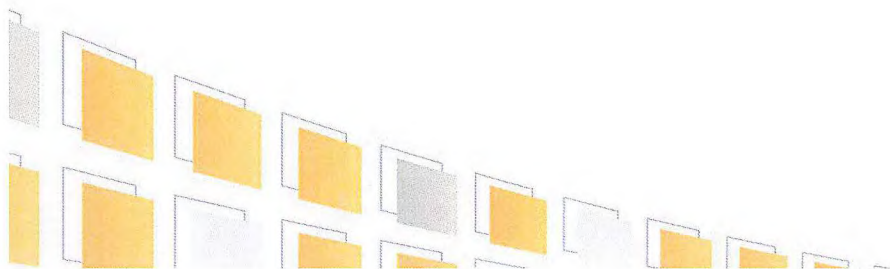
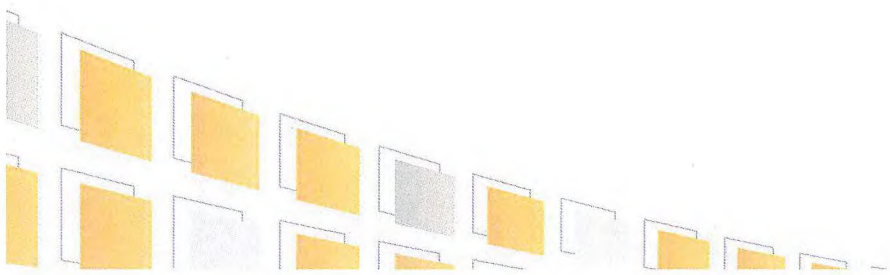
