On May 18, 2017, IRU Networks, LLC (“Applicant”) filed an application with the Missouri Public Service Commission for a Certificate of Service Authority to provide interexchange telecommunications services, classification as competitive, and waiver of certain Commission rules and statutory provisions. Applicant’s principal place of business is 3030 NW Expressway, Ste. 200-328, Oklahoma City, Oklahoma 73112. With its application, Applicant also filed a tariff with an effective date of July 2, 2017.

The Commission will direct its Data Center to send notice as set out in the ordered paragraphs below. The Commission will also set a deadline for any applications to intervene and will direct the Staff of the Commission to file a recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission’s Data Center shall send notice of this application to all telecommunications carriers certificated to operate in the state of Missouri.
2. Any appropriate person or entity wishing to apply to intervene shall do so no later than June 2, 2017.

3. The Staff of the Missouri Public Service Commission shall file its recommendation no later than June 13, 2017.

4. This order shall be effective when issued.
