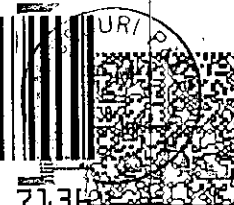

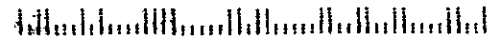

On July 12, 2005, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority to provide interexchange telecommunications services that was granted to Westex Communications, LLC, d/b/a WTX Communications, in Case No. LA-2003-0491. Staff's motion indicates that letters mailed to Westex have been returned by the post office as undeliverable and that the company has not provided the Commission with a current address. Staff also reports that the company's phone numbers have been disconnected, and that Westex has

never filed an annual report. Because of these failures, Staff asks the Commission to cancel WesTex's certificate and accompanying tariff.

The Commission will order WesTex to respond to Staff's motion. If the company fails to respond, Staff's motion may be granted without further notice.

IT IS THEREFORE ORDERED:

1. That WesTex Communications, LLC, d/b/a WTX Communications, shall file a response to Staff's Motion to Cancel Certificate of Service Authority and Accompanying Tariff no later than August 12, 2005.

2. That the Commission's Data Center shall mail a copy of this order by certified mail, return receipt requested, to the addresses listed for WesTex Communications, LLC, d/b/a WTX Communications, in the Commission's records, as indicated at the beginning of this order.

3. That this order shall become effective on July 13, 2005.
