ORDER CANCELING CERTIFICATE

Issue Date: June 11, 2019

On May 21, 2019, the Staff of the Missouri Public Service Commission filed a motion requesting Bradlie Business Service's ("Bradlie") certificate of service authority to provide shared tenant telecommunication service in the State of Missouri be cancelled.

In File Number TA-90-257, the Commission granted Bradlie a certificate of service authority to provide shared tenant telecommunication service in the State of Missouri.

Staff states in its motion that Bradlie contacted Staff via letter stating Bradlie was no longer providing service in Missouri and requesting the Commission cancel Bradlie's certificate of service authority. Staff recommends that the Commission cancel the company's certificate of service authority to provide shared tenant telecommunications services.

On May 28, the Commission issued an Order Establishing Time to Respond allowing parties until June 7, to file an objection or request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority granted to Bradlie Business Service shall be canceled.

THE COMMISSION ORDERS THAT:

- The certificate of authority to provide shared tenant telecommunications services granted to Bradlie Business Service, in File Number TA-94-23, is canceled.
 - 2. This order shall become effective on July 11, 2019.
 - 3. This case may be closed on July 12, 2019.
