ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: August 24, 2012

Effective Date: September 3, 2012

On August 10, 2012, the Staff of the Missouri Public Service Commission filed a motion requesting Switched Services Communications, LLC ("Switched Services") certificate of service authority and accompanying tariff to provide intrastate interexchange telecommunication services in the State of Missouri be canceled.

In File Number TA-95-386, the Commission granted Switched Services a certificate of service authority to provide intrastate interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. Mo No. 1, was also approved.

Staff states in its motion that the Commission approved a merger between Switched Services and IXC Services, the surviving corporation, on September 23, 1998. A motion to terminate Switched Services' certificate and tariff were to be filed within 60 days of the consummation of the merger. On May 10, 1999, the Missouri Secretary of State received notice that the merger between the two companies was effective on December 23, 1998. Staff indicates a motion to cancel Switched Services' certificate and tariff has not been filed with the Commission. Switched

Services is deficient in the filing of the Company's 1995 through 2011 annual reports. Staff recommends that the Commission cancel the Switched Services' certificate of service authority to provide intrastate interexchange telecommunications services, and the company's accompanying tariff.

On August 13, 2012, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing no later than August 23, 2012. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Switched Services Communications, LLC, shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide intrastate interexchange telecommunications services granted to Switched Services Communications, LLC, in File Number TA-95-386, is canceled.
2. Switched Services Communications, LLC's tariff, P.S.C. Mo No. 1, is canceled.
3. This order shall become effective on September 3, 2012.

4. This case may be closed on September 4, 2012.
