On November 9, 2022, Ozark Fiber, LLC pursuant to Section 392.550, RSMo, filed an application for registration to provide Interexchange Telecommunications Services in the following exchanges:

On November 17, 2022, the Commission filed a Notice of Deficiency due to the application being incomplete. On November 18, 2022, Ozark Fiber, LLC filed an amended Notice of Change Application correcting the deficiency.

The Commission has reviewed the application and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo. The affidavit attached to the application represents that the company has not had contact with the office of the Commission about any substantive issue connected to the filing within 60 days before filing the application. On the basis of that representation, for good cause shown, the Commission will waive application of the pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1).

THE COMMISSION ORDERS THAT:

1. Ozark Fiber, LLC is registered to provide Interexchange Telecommunications Services in the exchanges set forth in the affidavit attached to the application and restated above.
2. The pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1) are waived.
3. This order shall become effective on December 2, 2022.
4. This file may be closed on December 3, 2022.
