## ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: November 14, 2006 Effective Date: November 24, 2006

On November 3, 2006, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and tariff of Dial-Thru, Inc. to provide intrastate interexchange telecommunication service in Missouri.

In Case Number TA-99-478, the Commission granted RDST a certificate of service authority to provide intrastate interexchange telecommunications service. RDST's tariff, P.S.C. Mo. Tariff No. 1, was approved in the same case. In Case Number TO-2002-360, the Commission approved the change of name from RDST, Inc. to Dial-Thru, Inc. Dial-Thru has asked the Commission, through a letter from its consultant, to cancel its certificate of service authority.

Staff's motion states that Dial-Thru failed to file its annual registration report according to the Missouri Secretary of State's Office, and its authority to do business in the State of Missouri was revoked on January 24, 2004.

Staff's Motion indicates Dial-Thru owes no annual reports or assessments. No formal complaints have been filed against the company since the commencement of

the Electronic Filing and Information System, and any formal complaints or inquiries received have been closed.

Because Dial-Thru has requested cancellation of its certificate; it's not providing telecommunications service in Missouri; and it no longer has authority to transact business in the state, Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange telecommunications service and its accompanying tariff.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the request from the company's consultant and Staff's motion and recommendation, the Commission finds that the certificate of service authority and accompanying tariff granted to Dial-Thru shall be canceled.

## IT IS ORDERED THAT:

- 1. The certificate of service authority to provide intrastate interexchange telecommunications service, granted to Dial-Thru, Inc. in Case Number TA-99-478, is canceled.
  - 2. Dial-Thru's tariff, P.S.C. Mo. Tariff No. 1, is canceled.
  - 3. This order shall become effective on November 24, 2006.

4. This case may be closed on November 25, 2006.
