

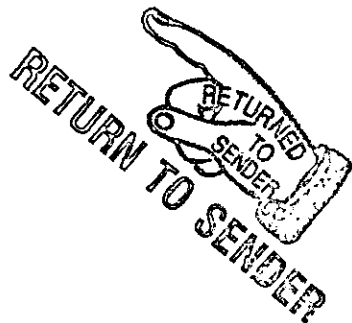

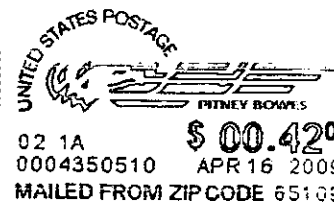

ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: April 16, 2009

Effective Date: April 26, 2009

On April 3, 2009, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority and the accompanying tariff of Advanced Telemanagement Group, Inc. ("Advanced"), a company that has been authorized to offer intrastate interexchange and nonswitched local exchange telecommunications services by the Commission.

In File Number XA-2004-0161, the Commission granted Advanced a certificate of service authority to provide intrastate interexchange and nonswitched local exchange telecommunications services. The Commission also approved the company's tariff, P.S.C. Mo. Tariff No. 1.

Staff's motion states that the Company requested the Commission cancel their certificate and accompanying tariff. According to the Missouri Secretary of State Office, Advanced was dissolved on administratively December 17, 2008.

One formal complaint is pending with the Commission, File No. XC-2009-0347, based on the Company's failure to submit a 2007 annual report.

Staff recommends that the Commission cancel the company's certificate of service authority and accompanying tariff, P.S.C. Mo. Tariff No. 1, to provide intrastate interexchange and nonswitched local exchange telecommunications services.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion to cancel the certificate and tariff, the Commission finds that the certificate of service authority and accompanying tariff granted to Advanced Telemanagement Group, Inc., shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide intrastate interexchange and nonswitched local exchange telecommunications services granted to Advanced Telemanagement Group, Inc., in File Number XA-2004-0161, is canceled.

2. Advanced Telecommunication Network's tariff, P.S.C. Mo. Tariff No. 1, granted in File No. XA-2004-0161, is canceled.

3. This order shall become effective on April 26, 2009.
4. This file may be closed on April 27, 2009.
