ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: January 11, 2011 Effective Date: January 21, 2011

On November 23, 2010, A.R.C Networks, Inc., d/b/a InfoHighway ("InfoHighway") filed an application, not signed by a Missouri attorney, requesting the Commission cancel its certificate of service authority and accompanying tariff to provide interexchange telecommunication service in the State of Missouri.

On November 30, 2010, the Staff of the Missouri Public Service Commission filed a motion requesting the Commission cancel InfoHighway's certificate and tariff stating the application is considered a statement that the company has ceased operations and are requesting the cancellation.

In File Number TA-97-385, the Commission granted InfoHighway a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. MO No. 1, was also approved.

Staff states in its motion that InfoHighway filed an application and construed the application to be a statement that the company ceased operations and is no longer in business. Staff recommends that the Commission cancel the company's

certificate of service authority to provide interexchange telecommunications services, and the company's accompanying tariff.

On December 3, 2010, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than December 13, 2010. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority and accompanying tariff granted to A.R.C. Networks, Inc. d/b/a InfoHighway, shall be canceled.

IT IS ORDERED THAT:

- 1. The certificate of authority to provide interexchange telecommunications services granted to A.R.C. Networks, Inc. d/b/a InfoHighway, in File Number TA-97-385, is canceled.
- 2. A.R.C. Networks, Inc. d/b/a InfoHighway's tariff, P.S.C. MO No. 1, is canceled.
 - 3. This order shall become effective on January 21, 2011.

4. This case may be closed on January 22, 2011.
