**WITHDRAWAL OF STAFF MOTION**

COMES NOW the Staff of the Missouri Public Service Commission and states as follows:

1. On January 4, 2011, the Staff filed a Motion to Cancel the certificate of service authority granted on December 1, 2005, to Unite Private Networks, LLC (“the Company”), because it reported no Missouri jurisdictional revenue for the past two years. Staff’s motivation for its filing was not to be punitive, but to merely remove those telecommunications companies not actively involved in providing services in Missouri to better maintain the Commission’s records.

2. On February 23, 2011, the Staff received the attached e-mail, in which the company indicates that it needs to maintain its Missouri certification as it has done business in Missouri and will be reporting Missouri jurisdictional revenue for 2010. The Staff’s Motion, if granted, would interfere with that business.

WHEREFORE, Staff withdraws its Motion to cancel the Certificate of Service Authority and tariff for Unite Private Networks, LLC and asks that this matter be closed without further Commission action.
