## MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY

**COMES NOW** Staff of the Missouri Public Service Commission ("Staff"), by and through the undersigned counsel, and moves for the Missouri Public Service Commission ("Commission") to cancel the certificate of service authority and associated tariff of Digizip.com, Inc. ("Digizip"). For its Motion, Staff states as follows:

- 1. On July 16, 2004, the Commission granted Digizip a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri in Case No. XA-2004-0594.
- 2. On March 28, 2013, Staff received Digizip's Statement of Revenue for calendar year 2012. (See Highly Confidential Attachment A). A note on the Statement of Revenue states "Final Return The company has voluntarily surrendered its certification on December 27, 2012."
- 3. On May 10, 2013, Staff of the Commission's Budget & Fiscal Services Department contacted Digizip to confirm that Digizip no longer wished to retain their certificate of service authority. On May 14, 2013, Digizip responded to Staff's email and requested cancellation of its certificate.

- 4. Because Digizip requested cancellation of its certificate and it is not providing services in Missouri to the best of Staff's knowledge, information and belief, Staff recommends that the Commission cancel the certificate.
- 5. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5, RSMo 2000, which provides "Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."
- 6. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. W.D. 1989).
- 7. Digizip is current on payment of fiscal year assessments and submission of annual reports.

**WHEREFORE**, Staff recommends that the Commission cancel the certificate of service authority and associated tariff of Digizip.com, Inc., to provide intrastate interexchange telecommunications services in the state of Missouri.
